The City of Evansville is focused on protecting the health of every household in our community. This notice contains important information about your drinking water. Please share this information with anyone who drinks and/or cooks using water at this property. In addition to people directly served at this property, this can include people in apartments, nursing homes, schools, businesses, as well as parents served by childcare at this property.

The Evansville Waterworks Utility has determined that a portion of or the entire water pipe (called a service line) that connects your property to the water main, has a material status of unknown. Our records do not indicate what the material is that your water service is made from. People living in homes with a lead service line may have an increased risk of exposure to lead from their drinking water.

Health effects of lead

Exposure to lead in drinking water can cause serious health effects in all age groups. Infants and children can have decreases in IQ and attention span. Lead exposure can lead to new learning and behavior problems or exacerbate existing learning and behavior problems. The children of women who are exposed to lead before or during pregnancy can have increased risk of these adverse health effects. Adults can have increased risks of heart disease, high blood pressure, kidney, or nervous system problems.

Your service line material is unknown; however, it may be lead. Because your service line material is unknown, there is the potential that some or all of the service line could be made of lead or galvanized pipe that was previously connected to lead. While the City will continue to replace the portion of all water laterals under the streets as part of reconstruction projects, the portion nearest your home is the responsibility of each homeowner to maintain and replace.

If your water service line is made of lead or galvanized steel, it's important to take steps to reduce your exposure to lead in your drinking water. We encourage you to:

- Visit the City's website at www.evansvillewi.gov/waterquality to either fill out a survey indicating the lateral material in your home (or request an in-home visit by City staff for assistance).
- Flush your taps for a few minutes each morning or after long periods of non-use prior to using the water for drinking and cooking.
- Clean your faucet's aerator (screen) regularly to remove sediment, debris, and lead particles.
- Use a water filter that is certified to remove lead.
- Use cold water from the tap for drinking. Do not use hot water.
- Contact a licensed plumber to replace your water service line. Some of you may have already done that – if so, please also let us know so the City-wide inventory can be updated. **If you have already replaced (or plan to) the private portion of the lateral (roughly from the sidewalk to your home), the City will need to replace the public portion (out in the street).**

Health effects of lead

Exposure to lead in drinking water can cause serious health effects in all age groups. Infants and children can have decreases in IQ and attention span. Lead exposure can lead to new learning and behavior problems or exacerbate existing learning and behavior problems. The children of women who are exposed to lead before or during pregnancy can have increased risk of these adverse health effects. Adults can have increased risks of heart disease, high blood pressure, kidney, or nervous system problems.

Your service line is made from galvanized material; and it may have absorbed lead. EPA has defined these service lines as "galvanized requiring replacement". If you have alternative information, contact us at 608-882-2288 or via email at water@evansvillewi.gov.

Galvanized service lines that have absorbed lead can contribute to lead in drinking water. People living in homes with a galvanized service line that has absorbed lead may have an increased risk of exposure to lead from their drinking water.

While the City will continue to replace the portion of all water laterals under the streets as part of reconstruction projects, the portion nearest your home is the responsibility of each homeowner to maintain and replace.
