3. **Agenda.** A motion was made by Dobbs, seconded by Senn, to approve the agenda as printed. Motion was approved 3-0.
4. **Minutes.** A motion was made by Senn, seconded by Dobbs, to approve the November 6, 2019 Public Safety regular meeting minutes. Motion was approved 3-0.

8. **Police Department Report.** Reese gave the monthly report covering the training for officers. The Old Fashioned Christmas went well. Shop with a Cop will be held on December, 14 2019. Lieutenant Reese and Becky from the youth center discussed an upcoming youth focus group event. Erin Conway from UW-Madison extension is hosting at the library. Erin is the Positive Youth Development Outreach Educator and has asked for our input. Community talks Art Gala was held at Emma's Table and Lieutenant Reese attended. Sergeant Jones conducted a training to Kids Korner Staff on how to identify various scams. For the fundraiser for Kadillac Kat Ranch the Police Department agreed to provide a child a ride in a squad car, tour of the Police Department and a goodie bag for one child as a raffle gift. Received a \$600 donation from a citizen that we will put to use by purchasing a bullet clearing device. Officer's Reilly and Johnson will be helping Milton Police Department with the Shop with a Cop December 5, 2019. Compliance checks were completed and all businesses passed. Calls for November were 887 in 2019; and 1253 in 2018.
9. **EMS Report.** Kessenich distributed the monthly report. 48 calls for service in the month of November 2019. 2019 year to date total calls for service are 566 and 535 in

2018. Evansville will be attending Rescue Task Force Training at the Mercy Prehospital Training Center in Janesville on December 9 or December 11. This training will be conducted by Mercy staff and will be along with Evansville Fire Department Personnel. EMT's will be able to practice while wearing the new tactical gear that was purchased in case of these types of incidents. (Mass Shooting in school or business or any other type of incidents that weapons are present.) The new ambulance has arrived and has been placed into service. Training took place November 12th at 5:30 pm, when it was delivered. Construction has begun on the bedrooms.
