# Recent and ongoing community development activities:

- Permitting for hail damage has been steady
  - Doing our best to help residents with insurance issues and contractors, especially in the historic district
  - Have reached out to DSPS for clarification on what is required regarding bringing a building up to code (which insurance has pushed back on, particularly regarding water-proof barriers
- Historic Preservation voted 3-3 on a resolution regarding the use of vinyl siding in the historic district. The Commission will revisit the resolution in July.
- Plan Commission discussed a handful of zoning revisions
  - A fee reductions/reimbursements for certain housing projects will be introduced, which would allow some building owners to qualify for WHEDA housing loans
  - Creates the "Studio or Instructional Service" use, which separates fitness, educational, and other group activities from the "Indoor Commercial Entertainment" use (restaurants, bars, etc) and allows them by right in most business districts, conditional in others
    - Good timing: we have 2 businesses out of compliance and another that wants to open in the Appliance Works space
- Park and Open Space Plan Update
  - Weather was great for a Walk Audit on the 24<sup>th</sup>. Initial consensus: Evansville's sidewalks range from excellent to non-existent and a whole lot of in-between.
  - o Consultant will be conducting focus groups at the end of month
  - o Community survey forthcoming
