7. New Business

A. Discussion and Updates Regarding Youth Center Director Vacancy. Sergeant informed of Becky Bartlett's departure last week and reminded the board to be mindful of email communications. Sergeant explained that a variety of circumstances has resulted in him appointing Angie Olsen, the current Aquatics Director, as the Interim Youth Center Director. The board discussed timeline of this change and scheduling of pool and youth center activities as it relates to Olsen's schedule. Sergeant shared the Youth Center and Pool operate on opposite seasonal schedules and Angie is prepared for some overlap in commitments. Angie would be in the position until year's end, and then likely continue into next year depending on budget discussion. Sergeant shared that Becky has been asked to partake in an exit interview, but employee's records are part of the employee's confidential personal file. Lathrop clarified that the Director is appointed by Administrator and Council, not directly by the board. The board also discussed fundraisers for the year. Sergeant shared he is unsure if the parade can actually happen and other fundraisers might be problematic. The board also discussed the prospects of programming and building space needs in the future as well as ways to best provide services to Evansville's youth. The board expressed a consensus of support with the interim appointment
