I understand my application must follow Section 130-541, including the regulations outlined below:

- No more than 6 female chickens (no roosters) on a lot zoned R1 containing a single family dwelling. The chickens shall be contained in a coop and run in backyard only.
- Not permitted on residential lots containing 2 or more dwelling units, in garages or dwellings. Also not permitted in front, side and street side yards or setback areas.
- Coop and run shall be a minimum of 10 feet from any residential structure
- A minimum of 4 square feet of coop space and 6 square feet of run space per chicken. Coop and Run cannot exceed 150 sq. ft. in area or 10 feet in height
- Permit Approval required before any work begins. On-site inspection required before chickens occupy coop and run. Electrical work requires an electrical permit and fee.
- Application for a chicken keeping permit must be submitted yearly for renewal. Permit shall be denied if applicant is in violation of Section 130-541 or Chapter 14 in previous 6 months.
