

Bulk Pick-Up Policy

Residents are allowed ONE bulk item per month on the designated day. If the item is more than one person can lift, please call ahead. Items not included in bulk pickup: Appliances, Construction Materials, E-Waste, Yard Waste, Hazardous Goods and Tires. Bulk items not picked up and remaining at the curb or in your yard for more than 3 Days are subject to code enforcement violations and penalties.

Yard Waste Curbside Collection & the Yard Waste Site

The City of Evansville provides two options to dispose of personal yard waste: Curbside Collection and the Yard Waste Site.

Curbside Collection:

New for 2026: Items must be at the curb by 8:00 a.m Monday morning. Only 1 pass will be made through the City.

Collection of branches, brush and yard waste debris is scheduled monthly on the first (1st) full workweek of the month from April 6th to October 5th. Grass clippings and small yard waste must be placed in a paper bag or a container that can be emptied and placed back onto the terrace. Please note: Plastic bags are not allowed and yard waste should never be placed in the street, as it can cause stormwater backups and flooding. *Plastic bags are not permitted.* Yard waste placed at the curb before April or after October is not picked up and remaining at the curb or in your yard more than 3 Days is subject to code enforcement violations and penalties.

Yard Waste Site / E-Recycling Dumpster: 465 Water Street (next to the Fire Station)

At this site you can dispose of grass clippings, leaves, branches and general yard waste. The Yard Waste Site is open seasonally April to November: Wednesdays, April 6th through November 18th from 5:00 p.m. to 7:00 p.m. and Saturdays, April 11th through November 9:00 a.m. to 2:30 p.m. **Items Not Accepted at Yard Waste Site:** Dimensional Lumber, Plastics, Hanging Baskets, Dirt and Regular Garbage.

E-Waste Guidelines: A list of the most common electronic devices in the rule is as follows:

Computers, Servers, Monitors, Televisions, Peripherals (Printers, Scanners, Keyboards, etc.), Memory/RAM - Computer Scrap - Power Strips and Surge Protectors - Hard Drives - UPS (Uninterruptible Power Supply) - Ink and Toner Cartridges - Office Equipment (Copiers, FAX Machines, Phones, etc.) - Cables, Wire, Connectors and Adaptors - Small Appliances (Microwaves, Toasters, Vacuums, etc.) - Consumer Electronics (VCRs, Stereos, DVD players, Cell Phones, etc.) - Media (CD, Floppy/Encased Diskettes, Storage Tape, etc.) - Network Equipment (Routers, Hubs, Switches, Modems, etc.) (Please refer to Wisconsin State Statute 287.07(5)(a) for the complete list of electronic devices that are regulated under this law.)
